

A guide to the nomination for the award of Life Membership of Parking Australia

The Parking Australia LTD Constitution defines 3 types of membership. Life Membership is defined as:

6.3 (d) Life Members

- (i) are persons who are appointed by the Board as a Life Member in recognition of services provided to the Parking Industry over a number of years; and
- (ii) shall not be entitled to vote.

Life Membership

Life Membership is a special form of membership which may be bestowed upon any natural person whose services to Parking Australia is agreed to have been sufficiently meritorious. Nominations for Life Membership, together with an appropriate support statement specifically detailing the nominee's involvement within Parking Australia (or the Parking industry) and contributions to it, must be submitted in writing to the Membership Committee at least six (6) weeks prior to a Board Meeting of the Company (or an agreed date if outside this timeframe). A voting member must make the nomination.

Nomination

The nomination must be made on the pro forma included with this guide. All relevant sections must be completed and no other form of nomination shall be acceptable. This nomination will form the basis of the citation to be awarded with the symbol of Life Membership as determined from time to time.

Parking Australia Process

Upon receipt of any nominations for this award, the Chief Executive of Parking Australia shall, refer the nomination to the Membership Committee. The Committee shall consider the merit of the nomination against the criteria, and make its recommendation to the Board of Directors as part of the agenda for a Board Meeting for acceptance and the award of the Life Membership. Life membership may also, with the approval of the Board of Directors be awarded at other times as the Board sees fit.

The Board reserves the right to decline a nomination without giving a reason.

Symbol of Award

The symbol of this award shall be a plaque (or such object as may be determined from time to time), and the Citation in a format suitable for framing, which will be presented to Life Member at a ceremony determined by the Board of Directors

Guide to Nomination Criteria

Life membership may be recommended for any highly meritorious contribution to the parking industry. The following do not attempt to be exhaustive guidelines, but rather to give ideas and scope to the types of contribution that could be rewarded.

- The nominee has made a significant contribution as a Parking Australia member over an extensive period of time (perhaps 10 years) in an active capacity as either a committee representative or on the board, or other capacity as indicated in the nomination form.
- The nominee has made a significant contribution to the sustainability of Parking Australia over an extensive period of time as a corporate sponsor (perhaps 10 years).

All details of the history of contribution should be included on the following nomination document.
